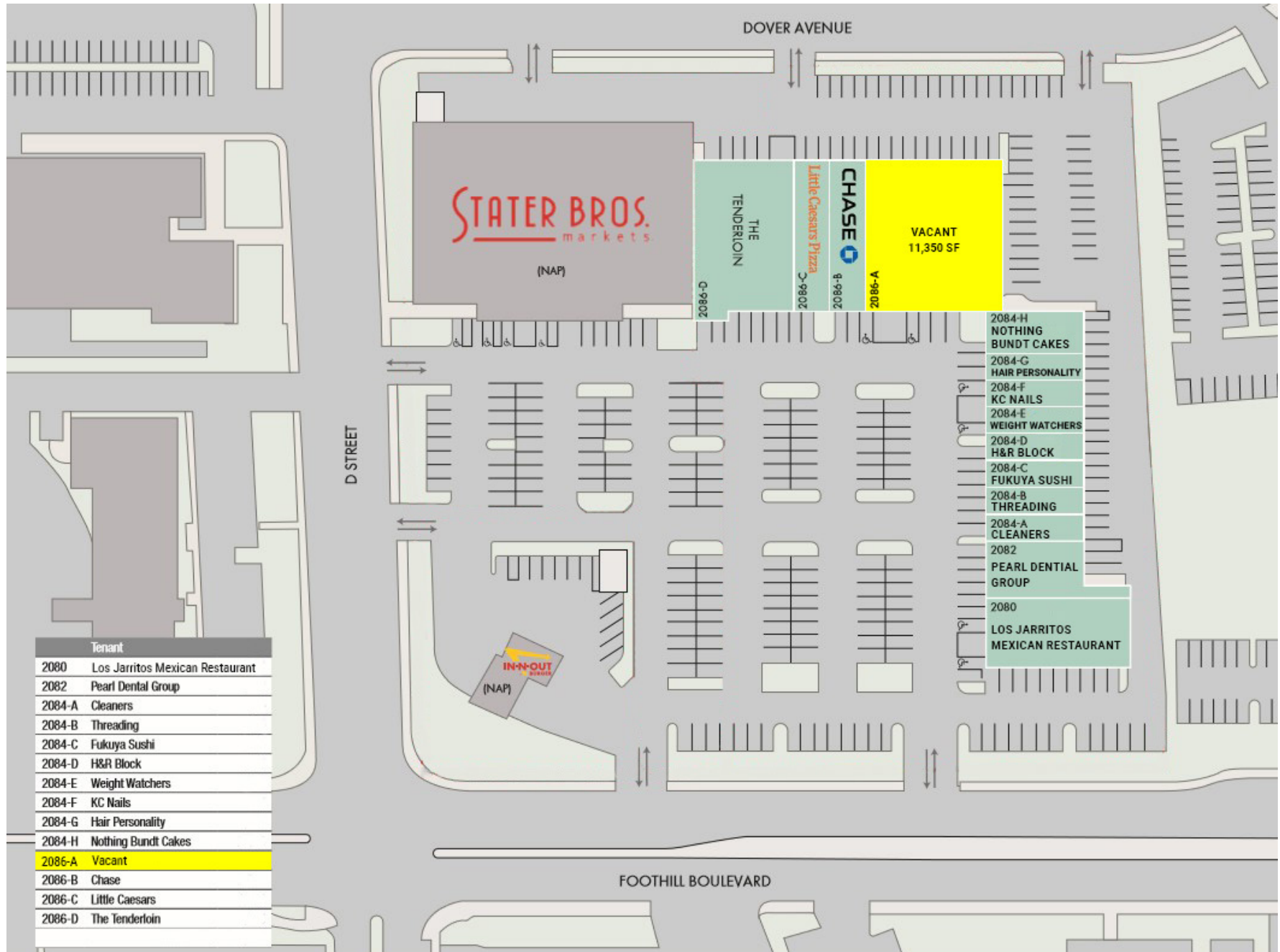

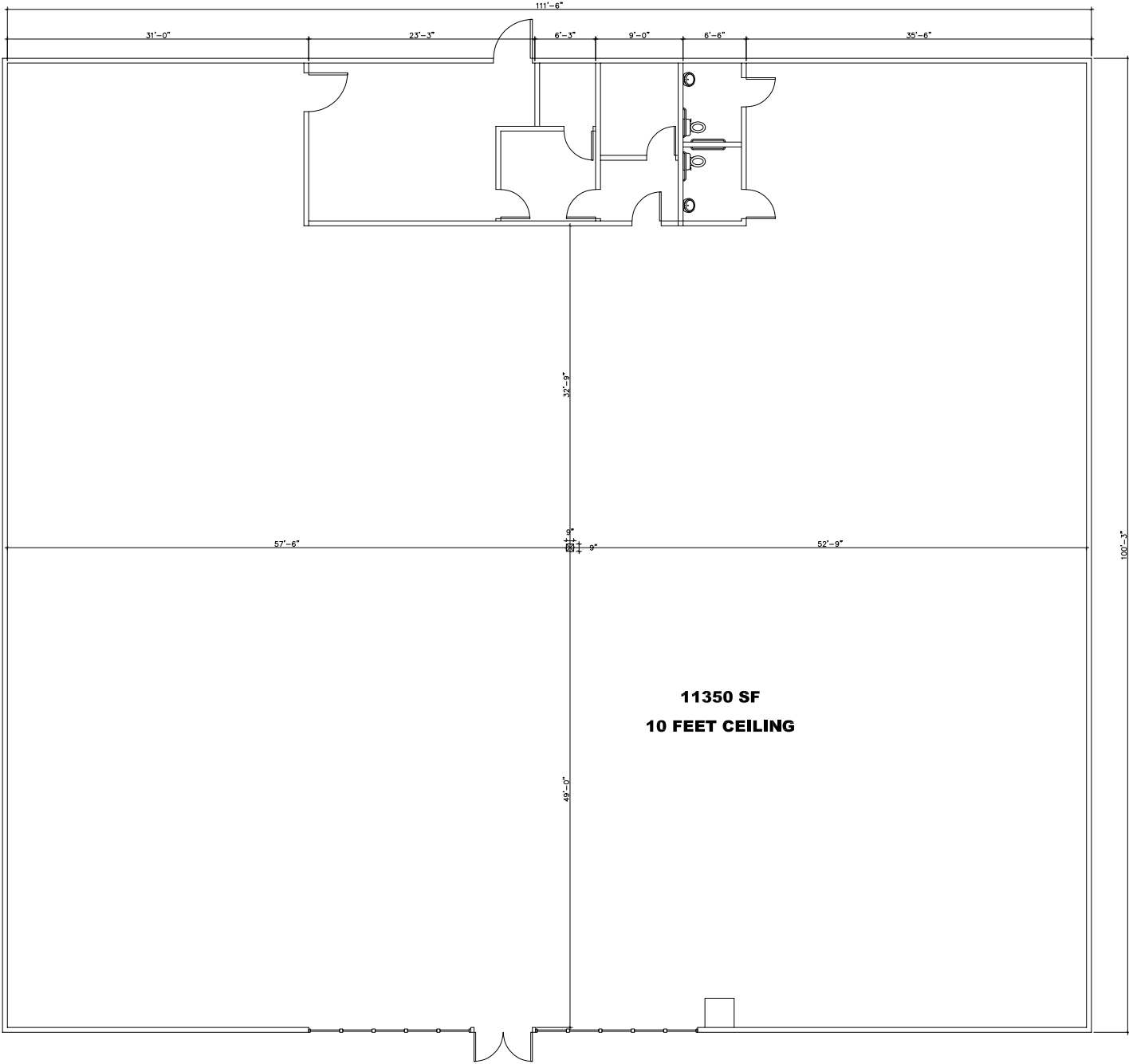

SITE PLAN - 2080 Foothill Blvd., La Verne, CA

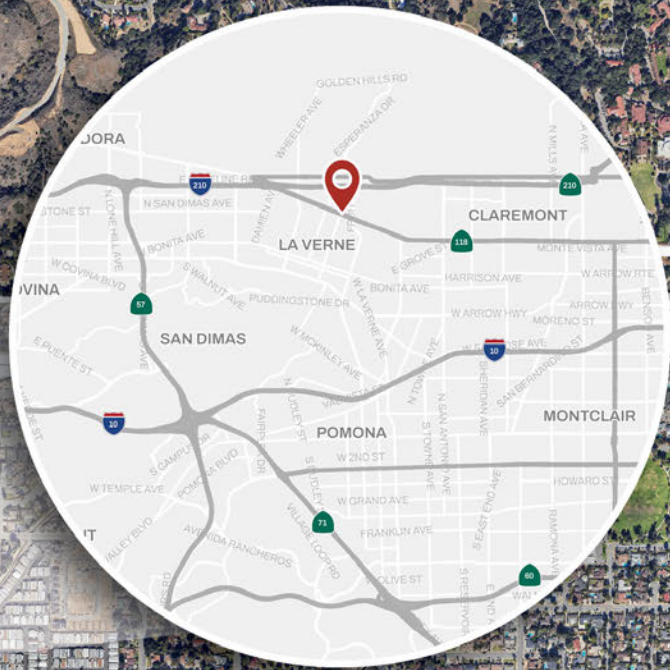


FLOOR PLAN - Unit A
