

Confidentiality Agreement

NAI Capital Commercial, Inc. (“NAI”) has been retained by Ramage Enterprises (the “Owner”) with respect to the offering of 8750 Tampa Avenue, Northridge CA 91324 (the “Property”) for sale (hereinafter referred to as the “Transaction”). The Owner has indicated that all inquires and communication with respect to the contemplated Transaction be directed to NAI. All fees due NAI Capital in connection with the Transaction of the Property shall be paid by the Owner.

NAI has available for review certain information concerning the Property which includes brochures and other materials (collectively “Informational Materials”). NAI will not disclose such Informational Materials to a Potential Purchaser (hereinafter referred to as a “Potential Purchaser”) unless and until said Potential Purchaser has executed this agreement. Upon NAI’s receipt of this executed agreement, NAI is prepared to provide the Informational Material for the Potential Purchasers’ consideration in connection with a possible Transaction subject to the following conditions.

1. All Informational Materials pertaining to the Property which may be furnished to a Potential Purchaser by NAI shall continue to be the property of the Owner and NAI. The Informational Materials will be used solely for the Potential Purchaser and may not be copied or duplicated without NAI’s written consent, which consent may be refused in NAI’s sole discretion, and must be returned to NAI immediately upon NAI’s request or when the Potential Purchaser terminates negotiations with respect to the Property.
2. Informational Materials may be disclosed to the Potential Purchaser’s partners, employees, legal counsel and institutional lenders (“Related Parties”), for the sole purpose of evaluating the potential Transaction.
3. The Potential Purchaser understands and acknowledges that NAI and the Owner do not make any representations or warranty as to the accuracy or completeness of the Informational Materials and that the information used in the preparation of the Informational Materials was furnished to NAI by others and has not been independently verified by NAI and is not guaranteed as to completeness or accuracy.
4. The Potential Purchaser hereby indemnifies and holds harmless NAI and the Owner and their respective affiliates and successors and assigns against and from any loss, liability or expense, including attorney’s fees, arising out of any breach of any of the terms of this Agreement.
5. The Potential Purchaser acknowledges that the Property has been offered for sale subject to withdrawal from the market, change in offering price, prior sale or rejection of any offer because of the terms thereof, lack of satisfactory credit references of any prospective purchaser, or for any other reason whatsoever, without notice. The Potential Purchaser acknowledges that the Property is being offered without regard to race, creed, sex, religion, or national origin. This agreement terminates one (1) year from the date hereof except as to written claims by Owner against Potential Purchaser prior thereto.
6. The Potential Purchaser represents that no broker or agent other than _____ represents us at this stage of the transaction. We acknowledge that NAI is not acting as our agent. Therefore, we will

not disclose any confidential information or specific acquisition strategy to NAI that may not be fully disclosed to the Owner.

7. In the event any legal action is commenced arising out of this Agreement, the parties agree as follows: (1) that it shall be heard only in the federal or state courts located in Los Angeles County, California; that (2) California law will govern; and (3) the prevailing party shall be entitled to recovery of its attorney's fees and costs of suit.
